ABOUT US

Mvusuludzo Projects (Pty) Ltd (MvusO) is an emerging, proudly South African and 100% black owned Company which is rated as a Level 1 B-BBEE Contributor with 135% Procurement Recognition.

The Company aligns its activities with various multi-national/disciplinary firms and financial institutions in order to enable it to tender for and execute large projects successfully. It further aligns its operations and programmes with well-established strategic partners, original equipment manufacturers and suppliers.

Although it is primarily a mining contracting entity, the Company is structured to also provide specialized turnkey services to its Clients on all construction, engineering, project cost analysis / estimating and project management assignments.

CURRENT MAJOR PROJECTS

A current mega project worth noting and which was awarded to MvusO in 2015, is the execution of the horizontal development package at the Palabora Mining Company's Lift II Project. At the time of award the magnitude of this scope of work was considered to be one of the largest projects of its kind under construction internationally.

The scope of work on this deep level underground mining project, with a budget of circa ZAR 2 billion, commenced during the 1st quarter of 2015 and is scheduled for completion during the 1st quarter of the year 2021. It entails some 32 kilometres of TMM tunnelling and construction of the related infrastructure to create a lower Block-Cave production platform (15ha) in order to extend the Life of Mine by some 18 years to 2033.

During the 2nd quarter of 2019, MvusO, in partnership with an international Tier 1 mining operator, was awarded the contract for the

execution of the Block-Cave Undercut package on the same project. This additional scope of work entails some 8 kilometres of TMM tunnelling, construction of some 217 production drawbells and some 800 000 metres of production long-hole drilling. This increased scope of work, at a budget of circa ZAR 3 billion, is scheduled for completion during the 4th quarter of the year 2022.

It is further worth noting that all work on the project, to date, has been completed without serious injury or loss of life. At the time of printing the project recorded a 60 month fatality free status with a lost-time injury frequency rate of 0.70 (LTIFR /200 000 hours).

The successful completion of this project will have a direct positive influence (socio-economic) on the livelihoods of some 150 000 people from within the local / surrounding communities.

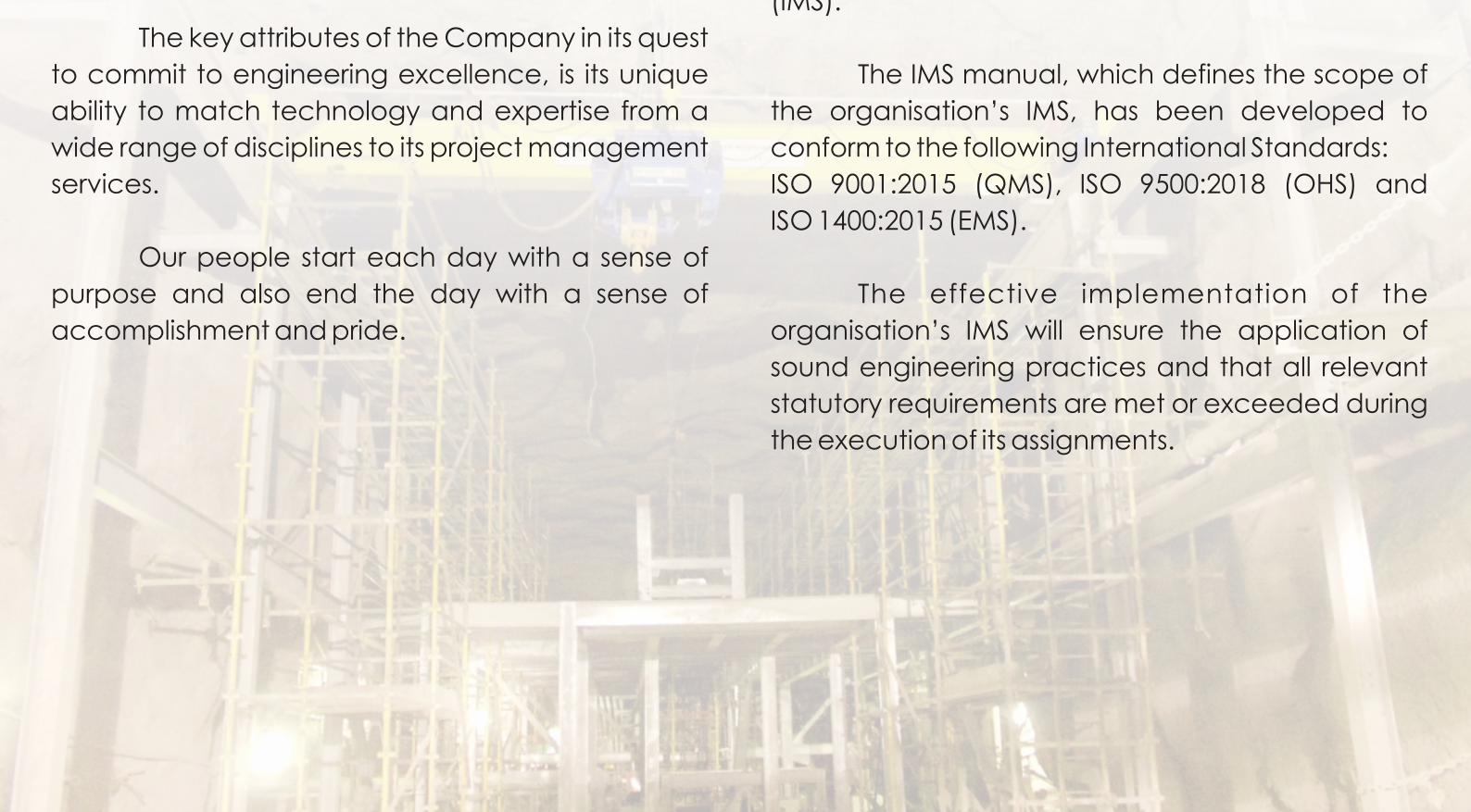
